
As planning to organize the 3rd Convocation of the University in near future is in process, the proposal was, therefore, put-up again for the consideration of the Academic Council.

Resolved:


The proposal was deliberated in detail. All the members of the Academic Council approved the proposal except representative from the Department of Law, Govt. of U.P. who was of the view that agenda cannot be approved till the final decision in the inquiry pending before the State Government is out which is against the entrance test and procedure adopted by the University through their byelaws for Ph.D. admission which are not in consonance with the UGC Rules in this regard. It is also stated by the representative from the Department of Law, Govt. of U.P. that University may write a letter to the Department of Higher Education Govt. of U.P. to know the present status of the inquiry.

During the deliberation, the Head of the Department informed the Academic Council that yesterday i.e. on 08.11.2019 viva of a Ph.D. Scholar namely Mr. Kamlesh Kumar was completed successfully and Viva report has been signed by herself and the Vice-Chancellor with the request that the name of this scholar be added in the list placed before the Academic Council. The request of the HoD was considered and approved by the Academic Council.
