ACADEMIC AND RESEARCH COLLABORATION AND COOPERATION


Sharing a common desire to explore, extend and strengthen the functional relationship between Universities & Institutions, **Babasaheb Bhimrao Ambedkar University (BBAU), Lucknow** and **Dr. Ram Manohar Lohiya National Law University, Lucknow** herewith sign a Memorandum of Understanding (MoU) which reads as follow:

1. Faculty members of **Babasaheb Bhimrao Ambedkar University, Lucknow** and Faculty members of **Dr. Ram Manohar Lohiya National Law University, Lucknow** may jointly start & run teaching programme in emerging areas and organize, conduct seminars/workshops/training courses, and submit collaborative research projects for funding to national and international agencies on relevant subjects, themes or topics on mutually agreed terms and conditions.
2. Research students working at either of the university will be enrolled and do research as per Ph.D. rules/regulations of the respective university.
3. Faculty members and Ph.D. students of BBA University Lucknow shall be extended the facility of consulting Books, Journals and reference materials available in the Library of Dr. Ram Manohar Lohiya National Law University, Lucknow. In accordance with the rules of the Institute; and likewise the faculty members and Ph.D. students of Dr. Ram Manohar Lohiya National Law University, Lucknow shall be provided the facility of consulting Books, Journals and other reference materials held by the University in accordance with the Rules of the BBA University, Lucknow.
4. The property right of students working at either university will be regulated as per rules and regulations of respective University.
5. The Memorandum of Understanding will be initially for 3 years & reviewed thereafter for continuation.
