Admission Notice to the Candidates allotted Dr. Ram Manohar Lohiya National Law University, Lucknow by CLAT Consortium (2025-26)

The candidates who have been allotted Dr. Ram Manohar Lohiya National Law University, Lucknow are required to complete the admission formalities through online mode as per CLAT Consortium website instructions and CLAT Calendar.

INSTRUCTIONS FOR ADMISSION TO THE CANDIDATES (CLAT-2025)

1. Candidates who have chosen the Freeze Option in the counselling process for First and Second Allotment Lists (First and Second rounds of counselling) are directed to adhere the schedule as notified by the CLAT Consortium and deposit the University Annual Fee (after adjusting for Confirmation Fee and Counselling Registration Fee) by **14th June 2025** as per following:

At the time of physical counselling ₹35,500 against mess fees in addition to the annual fees will have to be deposited to avail the mess facilities.

2. The fee must be deposited by using State Bank Collect payment gateway through the link <https://www.onlinesbi.sbi/sbcollect/icollecthome.htm?corpID=288415>. The candidates shall be required to select **Annual Fee** and enter their **Admit Card No. of CLAT 2025 in the column of Enrollment No.** while depositing online fee. Steps for online submission of fee are as follows: -

Visit the link given above → Select Category → Annual Fee → Course → B.A.LL.B-1st Year/LL.M.

3. The candidate shall also fill the Application Form through the link <https://forms.gle/HQTSrOgxVrVjan7r8>. The candidate is advised to secure the response copy of the submitted google form with him/her for future use.
4. The candidate is required to upload the scanned copies of the following documents:
 - a) CLAT-2025 Admit Card & Score Card.
 - b) Proof of payment of Counselling Fee and Confirmation fee made to CLAT Consortium.
 - c) Proof of payment of Annual Fee made to Dr. RMLNLU, Lucknow.
 - d) Mark sheet and Certificate of High School/Secondary School or any other Equivalent Examination.
 - e) Mark sheet and Certificate of Intermediate/10+2 examinations or any other Equivalent Examination.

- f) Mark sheet of final year of B.A. LL.B./B.A. LL.B. (Hons.)/LL.B. or any other equivalent degree from a recognized University in case of LL.M. Candidates only.
- g) Conduct/Character Certificate from the Institution/University last attended.
- h) Transfer/Migration Certificate from the Institution/University last attended.
- i) Soft copy of recent colour photograph of the candidate and signatures of candidate and parents/guardian. (.jpeg format)
- j) Affidavit for the year gap, if any.
- k) Valid caste certificate, issued by the competent authority of the State of UP, in case of reservation under categories of SC/ST/OBC/EWS (OBC caste certificate should not be more than 6 months old as on the date of counselling).
- l) Certificate applicable in the case of Horizontal Reservation. (Please see the note below)

Note:

- Candidates who have been admitted under various reserved categories namely 'SC/ST/OBC/EWS of UP' or 'SAP' or 'Sons/Daughters of Defence Personnel deployed in Uttar Pradesh or Defence Personnel of Uttar Pradesh either retired or killed/disabled in action' or 'Dependents of Freedom Fighters of Uttar Pradesh' will have to attach the scanned copy of original certificate issued by the competent authority in the prescribed format in support of their claims for reservation.
- OBC students must note that Caste certificate to be provided by them should not be older than six months.
- SC, ST & OBC Caste Certificate must also be verifiable from the website of Board of Revenue <http://bor.up.nic.in>.
- Dependents of Defence Personnel (Retired, killed or disabled in action) of U.P. should produce certificate issued by 'ZILA SAINIK KALYAN AVAM PUNARWAS ADHIKARI' in support of their claim for reservation.

RMLNLU Rules for refund of University Fee

1. Fees deposited by such candidates, who have been admitted through the Common Law Admission Test (CLAT), may be transferred to such other National Law Universities wherein they have been upgraded/shifted by CLAT in accordance with the procedure laid down by CLAT. If there are any dues pertaining to the student while studying in this University, it shall be deducted while transferring the fee to other NLUs from the amount of the fee deposited by him/her.
2. Students who withdraw their admission on their own volition before the closure of the admission process shall be eligible for a refund of the fee after deduction of the admission fee.
3. After the closing date of the admission process, the fee deposited by such a student who withdraws admission and leaves the University on his own will, either on account of his illness, absence from classes, failure in the examination or any other reason, shall not be refunded.
4. The caution money will be refunded to such a student after deduction of the dues, if any.
