INSTRUCTIONS FOR ADMISSION TO THE CANDIDATES (CLAT-2025)

1. Candidates are directed to deposit the mess fee as per the following:

Programme Name	Mess Fee to be deposited
B.A. LL.B. (Hons.) & LL.M.	Rs. 35,500.00

The fee must be deposited by using the *State Bank Collect* payment gateway through the link <https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=288415>. The candidates must select **Co-operative Mess** and enter their **Admit Card No. of CLAT-2025 in the column of Enrollment No.** while depositing online fees. The steps for online submission of the fee are given below: -

Visit the link given above ⇒ Select Category ⇒ Co-operative Mess ⇒ Course
⇒ B.A. LL.B. 1st Year/LL.M.

2. Candidates who have been offered admission under various reserved categories namely 'EWS/SC/ST/OBC of UP' or 'SAP' or 'Sons/Daughters of Defence Personnel deployed in Uttar Pradesh or Defence Personnel of Uttar Pradesh either retired or killed/disabled in action' or 'Dependents of Freedom Fighters of Uttar Pradesh' are directed to bring with them original certificates issued by the competent authority in the prescribed format in support of their claims for reservation. OBC students must note that the Caste certificate to be provided by them should not be older than **six months**. SC, ST & OBC Caste Certificates must also be verifiable from the website of Board of Revenue <http://bor.up.nic.in>. Dependents of Defence Personnel (Retired, killed or disabled in action) of U.P. should produce a certificate issued by 'ZILA SAINIK KALYAN AVAM PUNARWAS ADHIKARI' in support of their claim for reservation.
3. SC/ST/OBC/EWS/Unreserved candidates of U.P. having family income upto Rupee Two Lac per annum claiming Scholarship/ Fees Reimbursement shall be required to fill up their Scholarship/Fee Reimbursement Form online along with the necessary enclosure (i.e. income certificate (for the financial year 2024-25, caste certificate, photocopy of PAN Card/ITR of parents and affidavit in the prescribed format) through the website (<http://scholarship.up.nic.in>).
4. During the counselling the following documents shall be seen in original:
- Proof of payment of Counselling Fee/ Confirmation fee.
 - Proof of payment of Annual Fee & Mess Fee paid to the University.
 - High School/Secondary School Mark sheet and certificate.
 - Mark sheet and certificate of Intermediate/10+2 examinations.
 - Mark sheet for the final year of the B.A. LL.B., LL.B. or any other equivalent degree from a recognised university in the case of LL.M. Candidates.
 - Conduct/ Character certificate from the Institution/University last attended.

- g) Transfer/Migration certificate from the Institution/University last attended.
- h) Five colour photographs (2 passport size & 3 ticket size).
- i) CLAT-2025 Admit card & Score card.
- j) Affidavit for the year gap, if any.
- k) Valid caste certificate in case of reservation under categories of EWS/SC/ST/OBC of UP (OBC caste certificate should not be more than 6 months old as of the counselling date).
- l) One set of self-attested photocopies and the original certificates/documents mentioned above.
- m) [Admission Form](#) duly filled in and signed by the candidates.

Terms & Conditions of the Provisional Admission

1. The admission will be provisional and subject to the verification of all the information/facts given in the candidate's application form. Failure to report on the notified schedule will lead to the cancellation of the candidature for admission.
2. Only High School/10th Standard mark sheet/certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks shall be accepted for B.A. LL.B. (Hons.) Programme. For the LL.M. Programme, the mark sheet/Grade sheet of the LL.B. final year shall be seen to ascertain qualifying marks. No other documents shall be accepted in this regard.
3. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law of the land besides being debarred from appearing in any of the Entrance Test of the University in future.
4. Any attempt by the candidate or anyone else on his/her behalf to influence and/or pressurize any authorities/Admission Committee or University directly/indirectly for his/her out of rules admission shall disqualify the candidate from the admission. Such candidates shall also be liable to be prosecuted under the law of the land.
5. The provisional admission of the candidates to the course of study shall be subject to such rules and regulations as may be framed by the University from time to time.
6. Admission of the eligible candidates for the Specially Aabled Person (SAP) category shall be made only based on the certificate issued by the competent Medical Authority.
