- v. Transfer/Migration Certificate from the Institution/University last attended.
  - vi. Recent colour photograph of the candidate and signatures of candidate and parents/guardian.
  - vii. Affidavit for the year gap, if any
  - viii. Valid caste certificate in case of reservation under categories of EWS/OBC/SC/ST of UP (EWS of UP Certificate should be valid for FY-2025-26 and OBC caste certificate should not be more than 6 months old).
  - ix. Candidates who have been offered admission under various reserved categories namely 'EWS/OBC/SC/ST of UP' or 'SAP/PWD' or 'Dependents of Freedom Fighters of Uttar Pradesh' (DFF-UP) are directed to bring with them original certificates issued by the competent authority in the prescribed format in support of their claims for reservation. OBC students must note that the Caste certificate to be provided by them should not be older than **six months**. SC, ST & OBC Caste Certificates must also be verifiable from the website of Board of Revenue <http://bor.up.nic.in>.
5. At the time of counselling, if the candidate is found to be eligible for admission in B.A. LL.B. (Hons.), he/she will be required to pay the University Fees as follows:

## Terms & Conditions of the Provisional Admission

1. Only High School/10<sup>th</sup> Standard mark sheet/certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks shall be accepted for B.A. LL.B. (Hons.) Programme. No other documents shall be accepted in this regard.
2. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study if it is

found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law of the land besides being debarred from appearing in any of the Entrance Test of the University in future.

3. Any attempt by the candidate or anyone else on his/her behalf to influence and/or pressure any authorities/Admission Committee or University directly/indirectly for his/her rules of admission shall disqualify the candidate from admission. Such candidates shall also be liable to be prosecuted under the law of the land.
4. The provisional admission of the candidates to the course of study shall be subject to such rules and regulations as may be framed by the University from time to time.
