Inviting expression of interest for NRI/NRI Sponsored Categories in LL.M. Programme

Candidates seeking admission to the LL.M. (One Year) Programme under NRI/NRI sponsored* categories are hereby informed that they must send their expression of interest to Dr. Ram Manohar Lohiya National Law University, Lucknow, for admission under the said category against the vacant seat(s). Expression of interest should be submitted through the following link on or before **27th July 2025** :

- A one-time non-refundable application fee of **₹20,000.00** has to be paid by the candidate, and the same can be deposited by using the State Bank Collect payment gateway through the link <https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=288415>. The candidates shall be required to select the **Annual Fee** and enter their **Admit Card No. of CLAT 2025 in the column of Enrollment No.** while depositing the online fee. Steps for online submission of the fee are as follows: -

Visit the link given above → Select Category → Annual Fee → Course → B.A.LL.B-1st Year/LL.M.

- Expression of interest received after the last date or not in the prescribed format, or without payment of the application fee, is liable to be rejected. Shortlisted candidates shall be called for Counselling in the order of their CLAT-2025 All India Rank. The counselling date will be announced later on the Dr. RMLNLU website.
- All provisional admissions will be subject to physical verification of original documents by the University. Candidates are directed to send their complete contact details, including their phone number, email ID, etc., to enable the University to contact them for further necessary action.
- The prescribed fee for admission to the LL.M. (One Year) programme will be in accordance with the Brochure placed on the CLAT Consortium website. At the time of Counselling, the candidate will be required to deposit the annual fee prescribed for this category, which is given below:

Course	Annual Fees
LL.M. (One Year)	INR 50,000.00 + \$ 10,000

Candidates seeking admission under the NRI-sponsored category must ensure that the fee is paid from the account of the sponsor only.

Note: Preference shall be given to Foreign National/NRI candidates for the above seats

The candidate is required to be ready with the photocopies along with the original of the following documents for Counselling:

- A certificate showing the NRI status of the candidate ([Annexure-I](#)) or the NRI status of the person sponsoring the study, in case of NRI sponsored category ([Annexure-II](#)).
- CLAT-2025 Admit card & Score card.
- Mark sheet and Certificate of High School/Secondary School or any other Equivalent Examination.
- Mark sheet and Certificate of Intermediate/10+2 examinations or any other Equivalent Examination.
- Mark sheet of the final year of B.A. LL.B./B.A. LL.B. (Hons.)/LL.B. or any other equivalent degree from a recognized University.
- Conduct/Character Certificate from the Institution/University last attended.
- Transfer/Migration Certificate from the Institution/University last attended.
- Recent colour photograph of the candidate and signatures of the candidate and parents/guardians.
- Affidavit for year gap, if any
