## GENERAL TERMS & CONDITIONS

1. Candidates are required to report at the respective venue well in advance, carrying all requisite documents in **original** along with one set of **self-attested copies** for verification on the date of the interview.
2. Previous appointments/claimed experience have been evaluated in accordance with the provisions of the UGC Regulations, 2018 (Point No. 10.0 – *Counting of Past Services for Direct Recruitment*). Such experience shall be subject to verification, and candidates shall be **permitted to appear for the Interview** only upon submission of the following documents:
  - i. All valid salary slips from the period of employment; and
  - ii. An experience certificate clearly mentioning the mode of appointment (i.e., that the incumbent was appointed on the recommendation of a **duly constituted Selection Committee/Selection Committee** constituted as per the rules of the respective University) along with proof of pay scale offered during the tenure.
3. Candidates who have been found provisionally eligible with remarks shall be permitted to appear for the interview only upon submission of all requisite documents.
4. In-service candidates who have not applied through the “proper channel” shall be mandatorily required to produce a valid **No Objection Certificate (NOC)** from their present employer along with a **Vigilance Clearance Certificate** at the time of the Interview. Failure to furnish both documents shall render the candidate ineligible, and such candidates shall be disqualified from the selection process without further consideration.
5. Candidates claiming reservation under **SC/ST/OBC/EWS categories of Uttar Pradesh** must ensure that the **name of their caste/category, including its spelling**, as mentioned in the caste certificate, exactly corresponds with the name notified in the official lists published by the Government of Uttar Pradesh from time to time. Any variation shall render the certificate invalid.
6. Candidates claiming reservation under **SC/ST/OBC/EWS categories of Uttar Pradesh** are required to produce a valid Caste/Category Certificate issued by the competent authority of Uttar Pradesh, strictly in the prescribed format notified by the Government of Uttar Pradesh. Similarly, candidates claiming reservation under the **Persons with Disabilities (PwD/PH)** category must produce a valid Disability/Medical Certificate issued by the competent authority. Non-submission of valid certificates in the prescribed format shall render the candidate ineligible for reservation benefits.
7. Candidates claiming reservation under the **OBC category of Uttar Pradesh** are required to submit a valid caste certificate issued for the **current financial year**, in the prescribed format of the Government of Uttar Pradesh. The certificate must clearly state that the candidate does not belong to the “**creamy layer.**” Failure to produce such a certificate in the prescribed manner shall render the candidate ineligible for reservation benefits.
8. Candidates possessing a **Ph.D. Degree** awarded in accordance with the **UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations**,

**2009 or 2016** must submit a certificate in the prescribed format (Annexure-II) from the concerned University certifying compliance with the said regulations.

9. Candidates who are registered for the Ph.D. programme **prior to July 11, 2009**, shall submit a certificate in the prescribed format (Annexure-III) from the concerned University/Institute, in accordance with the provisions of the **UGC (3rd Amendment) Regulations, 2016** regarding minimum qualifications for appointment of teachers.
10. The **University reserves the right** to cancel, postpone, and/or modify the interview without assigning any reason.
11. **No TA/DA or accommodation** shall be provided for attending the Interview.
12. The Interview process may continue on the following day depending on circumstances; candidates are therefore advised to come prepared accordingly.
13. The **date and time of the Interview are tentative** and may be changed. Any change shall be notified only through the University website ([www.rmlnlu.ac.in](http://www.rmlnlu.ac.in)).
14. The **number of vacancies** notified in the advertisement is purely tentative. The University reserves the right to **increase or decrease the number of posts** at the time of selection.
