Instructions for Admission to the Ph.D. Programme-2025-26

Date of Admission

The candidates are required to report for Provisional Admission and complete the Admission related formalities on **18th October, 2025** at **10:30 A.M.** in the **Council Room, Administrative Block** of the University.

I. Payment of Fees and Other charges

Candidates are required to deposit the following fee

Hostel fee	25,000.00
Cautions Money	5,000.00
Total (without hostel fee)	85,000.00

Apart from the above-mentioned fee, the candidate required to pay Rs. 28,000.00 against advance Mess Fee (if availing hostel). The fee may be deposited every year by using **State Bank Collect** payment gateway. The link of **State Bank Collect** payment gateway is available on the University website. Fee through **State Bank Collect** can be paid by using online banking/Debit/ Credit Cards of any bank. *“The fee must be deposited by using State Bank Collect payment gateway through the link:*

The candidates shall be required to select Annual Fee and enter their Admit Card no. of RET 2025 in the column of Enrollment No. while depositing online fee. Steps for online submission of fee are given below: Visit the link given above Accept terms and conditions and proceed Select Category Annual Fee Course Ph.D.”

II. Necessary Documents

1. Candidates who have been offered admission under various reserved categories namely **P W D** and **SC/ ST/ OBC/ E.W.S.** of Uttar Pradesh are directed to bring with them original certificates in support of their claims for reservation. PWD candidate must submit the certificate concerned in original. OBC students must note that Caste Certificate provided by them should not be older than **six months**. E.W.S. Certificate provided by them should be for the current Financial Year. SC, ST & OBC/ E.W.S. Caste Certificate must also be verifiable from the website of Board of Revenue <http://bor.up.nic.in>.

2. SC/ST/OBC/UR/EWS candidates of U.P. having family income upto Rupee Two Lac per annum; claiming Scholarship/ Fees Re-imbusement shall also be required to fill-up their Scholarship/Fee Re-imbusement Form along with the necessary enclosure (i.e. income certificate, caste certificate, photocopy of PAN card/ITR of parents and affidavit in the prescribed format).
3. SC/ST/OBC/UR candidates of U.P. having family income upto Rupee Two Lac per annum; claiming fee reimbursement shall be required to produce Income Certificate issued by the competent revenue authority (**Student must note that the Income Certificate provided by them is not older than six months and shall be verified from the website of Board of Revenue <http://bor.up.nic.in>**).
4. Mark sheets and certificates in support of educational qualifications.
5. Conduct/Character Certificate from the Head of the Institution last attended.
6. Transfer/Migration Certificate from the Institution last attended.
7. Year Gap Affidavit, if any.
8. Five colour photographs (3 passport size & 2 ticket size).
9. One set of attested copies along with the original certificates/documents as mentioned above.
10. **Admission form** duly filled in and signed by the candidate.
11. RET-2025-26 admit card.
12. An Undertaking, in the prescribed format, of acceptance of the Terms & Conditions of the Admission, signed by the candidate & the parents.
13. A prescribed form of particulars for Proctorial Board duly filled and signed by the candidate. This form can be downloaded from the website.

The admission at the initial stage will be only provisional and subject to the verification of all the information/facts given in the candidate's Application Form.

Terms & Conditions of the Provisional Admission

1. The Admission of any candidate is liable to be cancelled without giving any further notice forthwith at any time during the period of the concerned course of study if it is detected that the candidate has/had produced fake/ forged certificate(s)/ document(s) or indulged in any act of misconduct/ indiscipline/ moral turpitude or has/had concealed any other relevant information at the time of seeking Provisional Admission. Such a candidate is also liable to be prosecuted under the law of the land besides being debarred from appearing in any of the examinations of the University in future.

2. Any attempt by the candidate or anyone else on his/ her behalf to influence and/ or pressurize any authorities/ Admission Committee or University directly/ indirectly for his/her out of rules, the University authority shall cancel his/her Provisional Admission.
3. No research scholar registered for Ph.D. Degree shall take up simultaneously any other course of study or any full-time employment; however, this limitation will not apply to the teachers of Dr. Ram Manohar Lohiya National Law University, Lucknow registered for Ph.D. However, this limitation will not apply after the expiry period of 3 years from the date of admission. A Candidate who is in service shall have to submit a relieving certificate of their employer on the date of admission. Otherwise, his/her admission would be cancelled. Thereafter he/she will not be entitled for admission to Ph.D. Programme.
4. The Provisional Admission of all the candidates shall be subject to such Ordinances, Rules and Regulations as may be framed from time to time by the University.
5. The University shall not be responsible in any manner for non- payment of the fee on time.
6. Admission to the Ph.D. Programme-2025-26 may be cancelled if the Ph.D. Scholar fails to successfully complete the Course Work.

Note: The above instructions are in continuation of instructions issued earlier to the candidates for the Ph.D. Programme-2025-26.
