Notice

The End Semester Examination of the University shall be over by 23.05.2009. Thereafter, in order to ensure proper maintenance of hostel building the white-washing and routine repairing works will be carried out during Summer vacations. I have, therefore, been directed to inform the students about the following:-

1. Students are required to vacate the hostels latest by 25.05.2009. After handing over the charge of their rooms to the Hostel Warden/Hostel Supervisors. **Leaving the hostel without handing over charge shall be treated as indiscipline and shall disqualify the student concerned for the hostel accommodation in the next academic session.**
2. Students shall be required to report back as per the schedule given below:



3. They shall be allotted hostel rooms on production of bank pay-in slip in respect of the payment of their annual fee and mess fee (for one semester).
4. Students shall be required to submit a admission form duly supported by the pay-in-slip in respect of the annual fee paid for the academic year 2009-10 and to complete admission formalities on the date of reporting.
5. Annual Fee & Mess Fee for one semester shall be as per the following details:

6. Students can pay this fee in any SBI branch throughout India. Students paying their fee in the University campus branch shall be exempt from the bank charges.
7. Mess Fee mentioned above is as per present arrangements with the service provider, which is likely to increase in the coming academic year, therefore, students must be prepared to pay the additional amount subsequently, if required.

Admission to the eligible students in the next academic session shall be given strictly as per the University rules and subject to the aforesaid conditions, therefore, students are advised to ensure compliance of the same.
