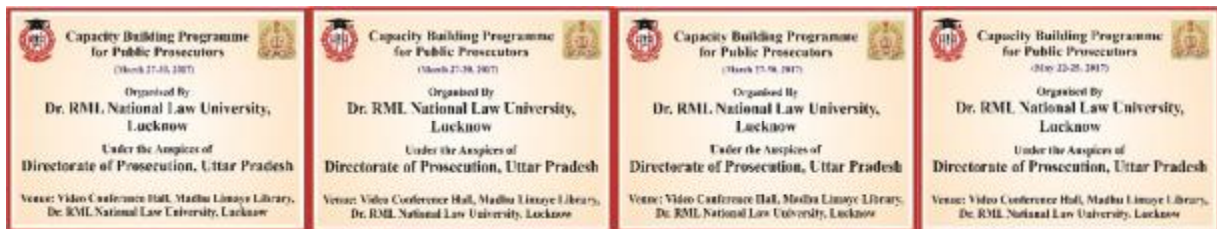


Capacity Building Programme for Public Prosecutors, 2017

Under the auspices of Prosecution Directorate, Uttar Pradesh, Dr. Ram Manohar Lohiya National Law University, Lucknow is organizing a fully residential '*Capacity Building Programme for Public Prosecutors*'. The first such programme was organized from March 27-30, 2017 and will continue till August 2017. The programme is divided in ten batches of fifty participants each. The programme is aimed at strengthening the professional capacity of the Public Prosecutors of Uttar Pradesh for effective discharge of their duties as a key player of the Criminal Justice System.



Public Prosecutors of all ranks from Joint Director (J.D.) to Assistant Prosecuting Officers (A.P.O.) are participating in this Capacity Building programme making it one of its kind vertical interaction programme. Subject experts and seasoned practitioners in different areas of criminal justice administration engage the public prosecutors in different sessions leading to a very lively and fruitful discussions.



In order to enhance the capacity of the public prosecutors in discharging their professional duties, a unique e-content comprising of Supreme Court decisions from 1950 to 2017 and decisions of Allahabad High Court from 1965 to 2017 as well as central and state legislations and fifty e-commentaries by renowned authors, is being provided to each participant on android

platform. The e-content may be used both online and offline. Updated All India Reporter e-content is also being provided to each participant.
