All the qualified candidates are advised to bring with them all the original documents in support of their claims as mentioned by them in the application form and one set of self-attested photocopy of all the relevant documents/Certificate is also required to be submitted during the document verification on the date of interview. If any candidates fail to produce original relevant documents/Certificate, he/she will not be allowed to appear before in the interview.
 3. Those candidates who have not submitted latest O.B.C. of UP Caste Certificate (not more than 06 months old), they must submit their latest O.B.C. of UP Caste Certificate on date of interview.
 4. Those candidates, who have not submitted EWS certificate (Financial Year 2023-24), they must submit their EWS of UP certificate on the date of interview.
 5. Those candidates who have not submitted Research Proposal/incomplete Research Proposal, they must submit their Complete Research Proposal on the date of interview.
 6. Those candidates who have not submitted LL.M. Marksheets/ LL.M. Degree in Proper Format, they must submit their LL.M. Marksheets/ LL.M. Degree issued by the concerned University on date of interview. Candidates whose PG result is still awaited will also be required to submit their final PG Marksheets/Degree on the date of interview. Such candidates are advised to get their marksheets/degrees collected from the concerned University before the Interview.
 7. Interview of the qualified candidates will start after the completion of document verification and the final merit list will be published on the University website on 06th September, 2023 (Wednesday).
